# The Chavey Down Association

The Association was formed some 59 years' ago in response to an outcry from local residents regarding plans to create a Cement Weigh/Batch Plant. A group of people in the village got together and formed the Chavey Down Association and its inauguration was in 1962. Since then the Association has gone from strength to strength and is highly regarded by Bracknell Forest and Winkfield Parish councils as well as the community it serves.

The CDA's aim is to maintain to preserve and to improve the amenities and rural character of the area; to foster and to encourage the growth of community spirit among the residents of Chavey Down and to protect the interests of the residents and their environment. The CDA endeavours to keep members of the association informed of local issues through newsletters, email and use of the CDA Noticeboard outside St Martin's Church.

Many of you have been members of the Association for many years but we have a number of new residents and we would love you to join us. The subscription fee is minimal and pays for the cost of producing newsletters and other running costs for the Association as well as going towards maintaining local amenities that are not provided by the Council.

# **Priory Road**

Some residents in Priory Road have indicated that there has been a marked increase in speeding, particularly over the past year, and would like the speed limit reduced to 30 mph. We would also need to implement some speed tracking sessions so would require volunteers (training would be given).

#### **Parking**

We have been asked to remind people to please park in a neighbourly manner. This means not blocking in cars or driveways, ensuring drivers have room to manoeuvre their cars and finally ensuring that drivers have clear visibility when exiting roads. We have also been asked to remind people that it is not safe for pedestrians to walk in the road in Long Hill Road, so please allow people enough space to use the pavements.

## Speeding

With the return of schools and more people returning to work, we are seeing a marked increase in speeding throughout the village. Unfortunately, much of this is coming from drivers using Priory, Long Hill, Church and North Roads as cut throughs to Warfield (to avoid the traffic lights at the Mercedes Benz garage). However, regretfully, it is also some Chavey Down residents. We have fought hard to get speed limits reduced due to requests from residents so kindly ask that everyone is conscious of their own speed when driving through the village. We therefore thought it useful to remind everyone of the current speed limits in the village:

Church Road 20	mph
North Road 20	mph
Chavey Down Road 30	mph
Locks Ride 30	mph
Long Hill Road 30	mph
Priory Road 40	mph

# Planning

The latest planning applications are as follows:

**21/00762/CL – Victor Lodge, 8 Church Road, SL5 5RR** – Certificate of lawfulness for conversion of loft into habitable accommodation with rear facing dormer, rooflights and erection of single storey rear extension. Pending consideration.

**20/00862/FUL – Orchard House, Priory Road, Ascot, SL5 8EB** – Erection of 7 no. 2 bedroom apartments following demolition of existing dwelling with associated parking, landscaping and entrance gates. Pending decision.

**21/00599/FUL - Beech Croft 27 Locks Ride** – Proposed erection of first floor to create first floor accommodation plus erection of single storey rear extension. Pending decision.

19/00847/OUT – Palm Hills, London Road. Demolition of existing Palm Hills complex and redevelopment of site to provide 81 dwellings (15no. one bedroom, 8no. two bedroom, 49no. three bedroom and 9no. four bedroom) with associated car parking, landscaping and amended access onto London Road.

The CDA, along with councillors Nigel Atkinson and Dorothy Hayes, objected to this planning application as the proposal is for an excessively large and dense development that is out of keeping with the local area and will intrude on neighbouring properties, as well as having negative impact on the environment. We also have significant concern about the impact on the local infrastructure and local roads. Finally, there is concern about its proximity to Strongs Wood landfill, the gas vents associated with it and the possible movement of leachate to the lower ground. Regretfully, the Inspector has overruled the Council's decision to refuse this planning application and has allowed the development to go ahead.
